## **SUNOMI INC. WARRANTY**

### **EXTENT OF LIMITED WARRANTY**

Sunomi Inc. warrants its products to be free from defects in materials or workmanship for a period of two years after original purchase date. This warranty only applies to the original owner and is not transferable. To obtain service under this warranty, you must send your Sunomi Inc. product together with original proof of purchase to **Sunomi Inc., 14626 87<sup>th</sup> Avenue, Surrey, BC, Canada, V3S 6R2**. Any postage, insurance or shipping costs incurred in sending your Sunomi Inc. product for service are your responsibility.

### **LOCAL LAW**

This warranty statement gives the customer specific legal rights. The customer may also have other rights which may vary from location to location. To the extent that this warranty statement is inconsistent with the local law, this warranty shall be deemed modified to be consistent with such law, where under such local law, certain disclaimers and limitations of this warranty statement may apply to the customer. For example, some states in the United States of America, as well as some governments outside of the United States (including provinces in Canada) may:

1. Preclude the disclaimers and limitations of this warranty statement from limiting the statutory rights of the consumer (e.g. United Kingdom).
2. Otherwise restrict the ability of a manufacturer to enforce such disclaimers or limitations.

### **LIMITATIONS OF LIABILITY**

Sunomi Inc.'s sole obligation under this warranty is to replace the product. The duration of any implied warranty or condition, of merchantability, fitness for a particular purpose, or otherwise, on this product shall be limited to the duration of the express warranty set forth above. In no event shall Sunomi Inc. be liable for any loss, inconvenience or damage, whether direct, incidental, consequential or otherwise resulting from breach of any express or implied warranty or condition, of merchantability, fitness for a particular purpose, or otherwise with respect to this product except as set forth herein. This warranty in no way replaces or is an extension of a complete bicycle manufacturer's warranty. Retailers and wholesale outlets for Sunomi Inc. products are not authorized to modify this warranty in any way.

### **LIMITATIONS OF WARRANTY**

1. This warranty does not apply to damage to the product caused by a crash, impact, abuse of the product, or when product has been subjected to forces or loads beyond its design.
2. This warranty does not apply when the product has been modified.
3. This warranty does not apply when the serial number or production code has been deliberately altered, defaced or removed.
4. This warranty does not apply to normal wear and tear and/or riding or installation in conditions or applications other than recommended.
5. This warranty shall not cover damages caused by the use of parts of different manufacturers.
6. This warranty shall not cover damages caused by the use of parts that are not compatible, suitable and/or authorized by Sunomi Inc. for use with Sunomi Inc. components.
7. This warranty shall not cover the labor required to remove and/or re-fit and re-adjust the product within the bicycle assembly.
8. It is the consumer's responsibility to regularly examine the product to determine the need for normal service or replacement.
